

## **Call for Nominations Editor-In-Chief ACM Transactions on Internet of Things (TIOT)**

The term of the current Editor-in-Chief (EIC) of the [ACM Transactions on Internet of Things \(TIOT\)](#) is coming to an end, and the [ACM](#) Publications Board has set up a nominating committee to assist the Board in selecting the next EIC to lead the publication. TIOT publishes novel research contributions and experience reports in several research domains whose synergy and interrelations enable the IoT vision. TIOT focuses on system designs, end-to-end architectures, IoT programmability, IoT real world deployments, and IoT enabling technologies. TIOT strives to publish innovative work with novel results and insights corroborated by a strong experimental component. Topics relevant to TIOT are listed on the Journal's [web site](#).

TIOT has been accepted for indexing in the Emerging Sources Citation Index (ESCI)<sup>TM</sup> by Clarivate Analytics, and its articles are discoverable on the Web of Science. TIOT's first impact factor is 2.7. The journal is also newly indexed and discoverable in [Scopus](#).

TIOT serves the SIGMOBILE, SIGBED, SIGAPP, SIGWEB, and SIGMOD communities, reflecting its broad, cross-research domain nature. Submission sources include the relevant SIG communities, which requires a well-diversified editorial board team.

Nominations, including self-nominations, are invited for a three-year term as TIOT EIC, beginning on April 1, 2024. The EIC appointment may be renewed at most one time. This is a voluntary position, but ACM will provide appropriate administrative support.

Appointed by the ACM Publications Board, Editors-in-Chiefs of ACM journals are delegated full responsibility for the journal's editorial management consistent with the journal's charter and general ACM policies. The Board relies on EICs to ensure that the journal's content is of high quality and that the editorial review process is both timely and fair. They have the final say on the acceptance of papers, the Editorial Board size, and Associate Editors' appointment. The [ACM Volunteer Editors Position Description](#) contains a complete list of responsibilities. Self-nominations are encouraged and should include a CV and a statement of the candidate's vision for the future development of TIOT.

The deadline for submitting nominations is March 1, 2024, although nominations will continue to be accepted until the position is filled. Please send all nominations to the search committee chair, Sumi Helal ([helal@acm.org](mailto:helal@acm.org)).
